Standards Operating Procedure for Kit 24h Procurement

Herewith a synopsis of the transactional procedure we employ, ensuring that all parties are exposed to minimal risk during the duration of the transactional process. The product in question shall be made available on a pre-ordered, ocean freight, DDP basis, subject to our synoptic terms of engagement and transactional procedures:

1. Signing NCNDA
2. All documentation must be addressed and sent to K24hSeller/JPBGTS
3. Essential initial documentation:
 - a. A Letter of Intent (LOI) (comprehensive and concise) with a transactional reference, and an exclusivity period of 10 business days (Business days defined as, Monday–Friday);
 - b. Irrevocable Corporate Purchase Order (ICPO) referenced to the LOI with the same transaction reference, and with the transactional terms and conditions, exclusivity period of 10 business days.
 - c. LOA indicate buyer finance capability to purchase the indicate qty in the LOI

Please Note: *We are able to provide templates that address all initial requirements above . In case SCF financing LOA is not necessary. Paperwork will be done via JPB Global Trade Solutions financing service*

3. Client On-Boarding, “Know your Client” (KYC) documentation with accompanying requisite documentation to be provided. Form to be completed with a list of documentation required, returned electronically for legal and onboarding purposes.
4. Upon Buyer verification, Seller FINAL Corporate Offer (FCO) provided to the client, shall be valid for a period of 72 hours from date and time issued and with reasonable indulgence due to the various Time Zones.

Note: The FCO is required to be signed and dated by the client, as acceptance of pricing, indicative delivery timelines and transactional terms and condition

It is important to note that the client, will, under this FCO, upon acceptance by way of signature, be attesting to being willing, ready and able to transact in all respects, with full corporate authority, and under penalty of perjury. (Kindly do not sign the FCO should you not be in a position to such attestation) The client, by signing said FCO shall be bound to such and to attend to and sign all such documents and further do all such things as may be reasonably and expediently to give effect to the provisions, intentions and spirit of the purchasing agreement.

6. Conference Call or Video Conference with Client and Seller to review approval, clarification of deal points if required and verification, and or any other matters that may be required to be addressed in such forum.
7. Sales and Purchase Agreement (SPA) issued, negotiated, signed, and returned within 48 hours.
8. Commercial Invoice issued to client.
9. 50% cash advance to the seller within 48 hours of signed SPA, (SCF: payment done by JPBGTS finance program)
10. Client will be provided with a Final Delivery Schedule – 24-48 hours after Seller's bankers confirm receipt and verification of the payments.
11. 50% final Payment to be paid on fulfilment of delivery as the product is delivered to Port in batches upon completion SGS / Buyer Inspection (option), SCF: payment done by JPBGTS finance programs
12. Waybill, Bill of Lading and Factory Packing List within 24-48 hours upon final deposit verified by Seller's bankers.
13. Stock dispatched from port of origin within 48-90 hours after the above process is completed.
14. Stock arrives at port of destination for the buyer (import of record) to be cleared
15. Client inspects the product received within 24h per each arrival and inspect for any damage.
16. Any cargo insurance claims within 48h with objective evidence such as pictures, driver verifications.
